Membership Classes

Applicants for membership shall be approved by the Board of Directors. The Board of the Association shall adopt Standing Rules for membership, and shall have the authority to establish qualifications, privileges for all classes of membership, except classes A, B & C. Pro-rated dues are 50% of the amount listed below for each class of membership.

- Class A** **Class A - Golf Course Superintendent.** To qualify for Class A membership, an applicant shall have at the time of application for membership, at least three (3) years experience as a Golf Course Superintendent and shall be presently employed in such capacity. Class A members shall have all the rights and privileges of the Association.

- Class B** **Class B - Golf Course Superintendent.** To qualify for Class B membership, an applicant shall be a Golf Course Superintendent who has, at the time of application for membership, less than three (3) years experience as a Golf Course Superintendent, and shall be presently employed in such capacity. Class B members shall have all the rights and privileges of the Association.

- Class C** **Class C - Assistant Golf Course Superintendent.** To qualify for Class C membership, an applicant shall be at \$170 the time of application for membership, an assistant to a golf course superintendent, and shall be presently employed in such capacity. Class C members shall have all rights and privileges of the Association.

- Class D** **Class D - Employees of Golf Course Superintendents.** To qualify for Class D membership, an applicant shall be \$50 at the time of application for membership, employed in a category other than assistant superintendent by a Class A, B or C member of the Association. Class D members shall have such privileges of the Association as the Board of Directors may specify by Standing Rules, except those of voting and holding office.

- Class E** **Class E - Educators.** This Class may be granted to research, legislative, and/or extension personnel connected \$0 with non-profit agencies. Class E members are exempt from dues and shall have such privileges of the Association as the Board of Directors may specify by Standing Rules, except those of voting and holding office.

- Class AF** **Class AF - Affiliate.** To qualify for this Class, an applicant must be affiliated with a company or proprietorship \$185 that is interested in golf course management, and which provides goods or services to Golf Courses and who supports the Association's objectives and enhances the image of this Association. Class AF members shall have all the rights and privileges of the Association as the Board of Directors may specify by Standing Rules, except those of voting and holding office.

- Class AS** **Class AS - Associate.** To qualify for this class, an applicant must be interested in golf course management and/or in the growing or production of fine turfgrass, and does not qualify for other classes of membership, but supports the Association's objectives and enhances the image of this Association. Class AS members shall have all rights and privileges of the Association as the Board of Directors may specify by Standing Rules, except those of voting and holding office.

- Class H** **Class H - Honorary Lifetime Membership.** This Class consists of those members of this Association who \$0 have retired from their respective professions and whom the Board of Directors shall deem deserving of this classification. Members of this Class shall have all the privileges of this Association afforded the Members of such individuals' immediate previous classification, with the exception of holding office.

- Class I** **Class I - Inactive.** An Inactive Member is a Member who, by reason of unemployment, illness or other adverse \$85 circumstances, has been placed in this class upon written application. The Executive Committee shall have the authority to act on such application and to place a member on inactive status subject to such terms and conditions as the Executive Committee may specify from time to time by Standing Rules; provided, however, that an Inactive Member shall not vote or hold office, Annual dues for this class shall be one-half the amount paid by Class A Members.

- Class R** **Class R - Retired.** Any member reaching age fifty-five (55) who is retired and is no longer seeking employment \$85 within the scope of activities of any membership class of this Association may apply to the Executive Committee in writing for Retired Membership. The annual dues for this Class shall be one-half the amount paid by Class A Members. A Retired Member can attend the Annual Meeting free of charge. A Retired Member shall have all the privileges of this Association afforded the Members in such member's immediate previous classification, with the exception of holding office.

- Class S** **Class S - Turfgrass Students.** This Class is available to persons currently enrolled in a Rocky Mountain area \$30 college or university where said student is studying Turfgrass science for the purposes of pursuing Turfgrass Management as a Profession. These persons must be full time students as defined by the college or university that said student attends. This Class carries neither voting nor holding office privileges.

- Class EM** **Class EM - Equipment Manager.** To qualify for Equipment Manager membership; an applicant shall be employed as an equipment manager, assistant equipment manager or mechanic/technician within the golf industry and shall have such rights of the association as the board of directors may specify by Standing Rules, except those of voting and holding office.
